Registration Information and Eligibility Criteria:

- 1. Friends and families attending the show MUST purchase tickets in advance for \$20 per person or at the door for \$25 per person. Tickets are available from any CFOFO Executive. Tickets include entry to the show and dinner (both vegetarian and non-vegetarian options will be available).
- 2. Deadline for registration is *11:59pm April 27, 2017*; however, please note that we are restricted to the number of artists that we can comfortably accommodate. As a result, registrations will be on a first come first serve basis.
- **3.** Please send completed registration forms to the 2017 YTS Committee via email at *info.cfofo@gmail.com*; or mail to #304-109 Tenth Street, New Westminster, BC V3M 3Y3.
- 4. Confirmation of your registration will be sent via email. All correspondence thereafter will be via email.
- 5. A friendly reminder that this is a family show. All artwork (e.g. painting, sketches, sculptures, etc.) should be appropriate for the event.
- 6. **Doors open to artists at 4:30pm**. Doors open to the general audience at 5pm. Show start time is 5:30pm.
- 7. Artists MUST be *between the ages of 4 and 25 years* to participate.
- 8. Parent/Guardian signatures must be present for all artists under the age of 19 years, in addition to the artist's own consenting signature. The artist and/or the parent/guardian hereby authorize CFOFO and agree that any information provided with this application and/or any tapes, video, photographs of the artwork shall become the property of CFOFO and may be used at their discretion for any purpose, including, but not limited to promotions, publications, fundraising events, etc.
- 9. Upon submission of this registration form, it is the artist's responsibility to obtain appropriate permission from their parents or legal guardians to participate in the CFOFO Youth Talent Show on May 27th, 2017 at the Khanna Banquet Hall (11267 125A Street, Surrey B.C.).
- 10. All artwork on display shall be at the risk of the individual artist and all artists absolve CFOFO, its' executives and volunteers for any injury incurred as a result of the artists participation in the event, and/or in the event of loss, theft or damage to personal property.
- 11. All artists should have their own general liability and accident insurance.
